ORDER:

The Registrar, Annapoorana Medical College & Hospitals, Sankari Main Road (NH-47), Veerapandi Union, Salem in his letter dated 01.07.2009 had forwarded Form I application along with the "Essentiality Certificate" issued by the State Government in Lr.No. 14427/MCA 2/2008-2, Health & Family Welfare Dept. dated 17.07.2008, to start I

01740987.2010 egree Course with an annual intake of 150 seats.

Based on the request of the Registrar, Annapoorana Medical College & Hospitals, Sankari Main Road (NH-47), Veerapandi Union, Salem an Inspection Commission was appointed to verify the infrastructure and teaching facilities available at the proposed "Annapoorana Medical College & Hospital, Salem" for issuing Letter of Consent of Affiliation for starting 1st M.B.B.S Degree Course with an annual intake of 150 seats. Based on the Inspection Report, "Letter of Consent of Affiliation" was issued on 1.7.2009 pending approval of the Governing Council. The Governing Council has ratified the action of having issued the "Letter of Consent of Affiliation" in its 190th meeting held on 24.07.2009.

The Vice-Chairman, Thirumuruga Kirupananda Variyar Thavathiru Sundara Swamigal Medical Educational and Charitable Trust had requested this University on 10.05.2010 to issue a fresh consent of affiliation for the year 2010-11 since the Medical Council of India is insisting for a revised Letter of Consent of Affiliation for the academic year 2010-11. Based on the request of the trust, a fresh consent of affiliation was issued on 10.05.2010. The Governing Council ratified the action of having issued the fresh "Letter of Consent of Affiliation" in its 198th meeting held on 14.07.2010 to start a new Medical College in the name of "Annapoorana Medical College & Hospital, Salem" with an annual intake of 150 seats.

In letter No.MCI-No.34(41)/2011-Med./16451 dated 08.6.2011 the Medical Council of India, New Delhi has conveyed the approval of the Board of Governors for establishment of a new medical college at Salem, Tamilnadu in the name and style of "Annapoorana Medical College & Hospitals, Salem, Tamilnadu" by Vinayaka Missions Research Foundation Trust, Salem, Tamilnadu with an annual intake of 150 (One Hundred fifty) students from the academic year 2011-12.

Based on the Medical Council of India approval an inspection Commission consisting of Dr. G.Ilangovan, M.D.,D.D.,Ph.D., Former Director of Medical Education, Prof. of Dermatology, Rajiv Gandhi Government General Hospital as Convenor and Dr. G. Thulasi Kumar, M.S.,(GS), M.Ch., Prof. of Vascular Surgery, Madurai Medical College, Madurai as member was appointed and the inspection team has inspected the college on 15.7.2011, for considering the grant of Provisional Affiliation to start First MBBS Degree Course.

Based on the report of the Inspection Commission and on the approval of Medical Council of India, New Delhi, the University is pleased to grant Provisional Affiliation to the Vinayaka Missions Research Foundation Trust, Salem, Tamilnadu for starting a new Medical College viz., "Annapoorana Medical College & Hospitals, Salem, Tamilnadu" with an annual intake of 150 (One Hundred Fifty) students from the academic year 2011-12, subject to the approval of the Governing Council, and the conditions given in the annexure.

The Institution code allotted is 491.

ANNEXURE-I

The Provisional Affiliation is granted subject to the following conditions:

 The sanctioned strength for the MBBS Degree Course is 150 (One Hundred and Fifty) from the academic year 2011-12. The maximum number of students that may be admitted to the course shall not exceed the sanctioned strength.

- The admission procedure as enunciated by the Supreme Court of India, shall be followed.
- The admission procedure as laid down in G.O.(D) No.557, Health and Family Welfare (MCA1) Department dated 07.06.2011 should be followed:
- 4. "Annapoorana Medical College & Hospital" Salem shall abide by the provisions of the Tamilnadu, Dr. M.G.R. Medical University Act, 1987 (Tamilnadu Act 37 of 1987) and by Statutes, Ordinances, Regulations and Rules of the Tamil Nadu Dr. M.G.R. Medical University applicable to the medical colleges framed from time to time.
- Only eligible candidates according to the regulations of this University shall be admitted to the first year MBBS Degree Course for the academic year 2011-12. While making admission, the rule of reservation of the Government of Tamil Nadu shall be adopted strictly.
- 6. The candidates should be admitted in the capacity of 150 seats before the prescribed cut off date for MBBS Degree Course and they will be registered to take up their I Year examination as per existing regulations. There will not be any admission after 30th September 2011.
- 7. The Institution should undertake to abide by the provisions of the Tamil Nadu Dr. M.G.R. Medical University, Chennai, Act, 1987 (Tamil Nadu Act 37 of 1987) and by the Statutes, Ordinance, Regulations and Rules of the Tamil Nadu Dr. M.G.R. Medical University applicable to the Medical Colleges framed from time to time.
- 8. The conditions that may be prescribed by the Medical Council of India shall be fulfilled. The standard and requirement prescribed by Medical Council of India from time to time for admission to Medical Colleges shall be followed strictly.
- The College shall abide by any other conditions which the University may consider necessary and impose from time to time.
 - 10. Only qualified staff shall be appointed to handle the classes. No unqualified staff shall be appointed.
- 11. Only eligible candidates according to the regulations of this University shall be admitted.
 - 12. While making admission, the rule of reservation of the Government of Tamil Nadu shall be adopted strictly.

13. The Institution shall obtain the recognition of the Medical council of India for 150 seats and submit the copy of the same to this University.

14. The Institution shall furnish a budget for each year of study and a separate development budget which will cover the expenses for the fulfillment of the

requirements prescribed in the entire course of study.

15. The staff, student ratio prescribed by the Medical council of India shall be followed. The staff pattern with prescribed qualification by the University as well as the Medical Council of India should be followed.

16. The Institution shall obtain the renewal permission of the Government of India for an intake of 150 seats every year and submit the copy of the same to the

University.

17. Hostel accommodation shall be made available for the students.

18. Required furniture shall be provided wherever they are necessary.

19. There shall not be any financial commitment either to this University or to the Government.

20. Furnishing of false information to the University any matter or suppression of facts while furnishing information to the University or violation of any of the Statues, Ordinances, Regulations, Rules, Instructions or conditions of affiliation shall result in withdrawal of the Affiliation of the College.

21. The Institution shall furnish all the teaching and other staff details with qualification, experience, date of joining etc. whenever required by the University.

22. The course should be conducted to accordance with the regulation and syllabi approved by this University and Medical Council of India.

23. Facilities should be made available for conducting University Examinations.

24. The Medical College shall have a duly constituted Governing body with a representative of the teaching staff to advise the Principal in the affairs of the College. A record of proceedings of the said Governing Body of the College shall be maintained by the Principal.

25. The Governing Body of the college shall meet atleast once in every three months to consider the budget estimate and such other matters as may arise in its working. It shall meet in May-June each year to consider the Annual Report, the audited statement of accounts, changes in the staff, subjects or courses in which fresh affiliation or approval is to be sought in the following year.

26. The Security Deposit of Rs.40,00,000/- each for the Second and Third instalment

should be created for newly created Medical Colleges.

27. After fulfilling all the conditions required to be fulfilled by the college under the Tamilnadu Dr. M.G.R. Medical University (Affiliation of Medical Colleges) Statutes, by the end of I year MBBS Degree course of Study, the Institution shall apply to this University for the grant of Continuance of Provisional affiliation for the Second year MBBS Degree Course of study.

28. The candidates should be admitted before the cut off date i.e. 30.09.2011 fixed for all the institutions, which are running MBBS Degree Courses.

29. During the University Examinations, the question paper will be sent through internet for which the following equipments have to be purchased and kept ready by the Institution.
