### PREAMBLE :-

In the reference 1st cited, Vinayaka Missions Research Foundation Trust, Sankari Main Road (NH-47), Ariyanoor, Salem – 636 308 has obtained Government Order from Health and Family Welfare Department, Secretariat, Chennai, Tamil Nadu for the purpose of establishing a new Medical College in the name and style of Annapoorana Medical College & Hospital, Sankari Main Road (NH-47), Veerapandi Union, Salem - 636 308 to conduct M.B.B.S. Degree Course with an annual intake of 150 seats for the academic year 2008-2009.

- 2. In the reference 2<sup>nd</sup> cited, this University has granted Provisional Affiliation orders to Annapoorana Medical College & Hospital, Salem for the starting of MBBS Degree Course with an annual intake of 150 students from the academic year 2011-2012, as per the approval granted by the Medical Council of India. The same was approved in the 207<sup>th</sup> Governing Council Meeting held on 27.09.2011 in the 3<sup>rd</sup> cited.
- 3. In the reference 5<sup>th</sup> cited, this University has granted Conditional Continuance of Provisional Affiliation orders to **Annapoorana Medical College & Hospital, Salem** for conducting MBBS Degree Course with an annual intake of 150 seats for the academic years 2017-18, 2018-19, 2019-20 & 2020-21, subject to fulfill the conditions stipulated by the Government of India, New Delhi. The same was approved in the 278<sup>th</sup> Governing Council meeting held on 17.11.2020 in the reference 4<sup>th</sup> cited.
- 4. In the reference 12<sup>th</sup> cited, this University has granted Provisional Affiliation orders to Annapoorana Medical College & Hospital, Salem for starting of Five (05) new Specialities in M.D. Post Graduate Degree Course for academic year 2022-2023. The same was approved in the 294<sup>th</sup> Governing Council Meeting held on 13.12.2022 in the reference 13<sup>th</sup> cited.

- The Seat Matrix was also informed to the Selection Committee for the academic years 2021-22 and 2022-23 for M.B.B.S. and M.D. & M.S. PG Degree Course.
- The Dean, Annapoorana Medical College & Hospital, Salem has remitted the required fee in M.B.B.S. course for the academic year 2021-22 & 2022-23 through online RTGS / CMS2 portal.
- 8. Based on the Resolutions passed at the Governing Council Meeting in the references 6<sup>th</sup> & 9<sup>th</sup> cited, the Institution has been instructed to upload the necessary documents in the Affiliation Module of CMS-2 portal and further, the Inspection has been conducted for two days on 04.05.2023 & 05.05.2023 and submitted its report on the infrastructural, teaching and other facilities available at Annapoorana Medical College & Hospital, Salem for grant of Continuance of Provisional Affiliation for conducting M.B.B.S for the academic years 2021-22 & 2022-23.

#### ORDER:

In pursuance to the Resolutions passed by the Governing Council, Letter of Permission / Conditional Recognition & Confirmation order for Recognition granted by Medical Council of India / Government of India / National Medical Commission, New Delhi, inspection report submitted by the Inspection Team, data uploaded in the CMS2 portal and receipt of the required fee, this University hereby grants the orders of Continuance of Provisional Affiliation to Annapoorana Medical College & Hospital, Sankari Main Road (NH-47), Veerapandi Union, Salem - 636 308 for conducting M.B.B.S. Degree Course with an annual intake mentioned against each for the academic year 2021–2022 & 2022-23, subject to the following conditions:-

- To fulfill all the requirements (infrastructural, teaching and other facilities available) in the CMS2.0 portal;
- ii) To rectify any other deficiencies pointed out in the report of the Inspection Commission and data submitted in the portal;
- To abide the prescribed Rules / Guidelines of the Statutory bodies/Government of Tamil Nadu and the Affiliation Statutes of the Tamil Nadu Dr. M.G.R. Medical University, Chennai, imposed from time to time;
- iv) The University may conduct inspection to verify the above if required and
- v) The usual conditions already intimated in the Provisional Affiliation orders of this University.
